## Scar Revision

### THE PROCEDURE

Because every scar is different, individual treatments vary and may include four separate FDA approved LASERS. Pigment, blood vessels and redness are treated to create an even tone. Deep Collagen Stimulation tightens and improves the skin's texture, and LASER peels smooth the surface.

### THE RESULTS

Whether your scar is from trauma, surgery, or acne you will see improvement. Scar treatment requires a treatment every 4-6 weeks for 6 months or more.

### THE PAIN

Pain may be none to moderate. A topical anesthesia is applied and is usually enough to control the pain. Oral pain and anti-anxiety medication are available if needed.

### THE COST

Cost is \$200-\$600 per treatment and will depend on the size and severity of the scar.
